Police Chief Ronnie Murray stated he had a vacant spot he would like to fill. An Applicant who was over the age of 60 and post certified and has 10 years law enforcement experience. ## 13. UPDATE BY TOWN ATTORNEY REGARDING ALCOHOL SALES WITHIN THE MUNICIPAL LIMITS OF THE TOWN OF PLAIN DEALING

#### **Minutes:**

Town Attorney Doug Dominick stated he wanted to address how low and high octane alcohol sales would be allowed in the Town of Plain Dealing. The Town is currently sitting with low content sales in the city limits of the Town. The only way to have high content alcohol sales in the city limits would be to have a vote by the people. To add to the ballot, there must be a petition that the registered voters must sign. There are five proposition's that must be on the ballot. Mr. Dominick reviewed what those proposition's cover. We are still reviewing the Town's record's to find the original proposition concerning the sale of alcohol content. Mr. Dominick stated the petition when we get to that point needs to be sponsored by a citizen not on the board. Mr. Dominick also addressed that there is no zoning in the Town of Plain Dealing.

#### 15. Water & Sewer Superintendent-- Monthly Report

#### Minutes:

Water & sewer Superintendent Steve Smith gave a monthly report consisting of an update on the S. Perrin Bridge. Mr. Smith stated that he had a meeting with Butch Ford, Mark Coutee and the Police Jury. The Police Jury stated they would help the Town pay for the repair. It would be cheaper for us to build another bridge, verses placing rail cars under the bridge. Mr. Smith stated that either way the Town makes the repair the utilities will have to be moved because OSHA says you cant run heavy machinery within 20 foot of the power lines. Mr. Smith stated that there was a meeting scheduled with the Utilities the week of the snow storm so the meeting obviously has been postponed. Mayor Murray stated that she has a meeting scheduled Thursday with the Police Jury to discuss assistance with the bridge. Mr. Smith stated that the engineers have given him a rough estimate of 50,000 for cost to replace the bridge. Mrs. Melody with Cenla Environmental presented a MWPP Resolution that must be completed annual. The resolution is as follows: MWPP Resolution Resolved that the Town of Plain Dealing informs the Louisiana Department of Environmental Quality that the following actions were taken by Town Councilmen: 1. Resolved the Municipal Water Pollution Prevention Environmental Audit Report for January 2020 — December 2020 which is attached to this resolution. 2. Set forth the following actions necessary to maintain permit requirements contained in the Louisiana Pollution Discharge Elimination System (LPDES) permit, Number LA002004. 3. To continue being good environmental stewards by maintaining our wastewater treatment plant and continuing required analytical analysis in accordance with our current LDEQ permit, including monthly monitoring of influent CBOD. 4. Continue to seek funding for improvements and reconstruction as needed. A Motion by Alderwoman E. Jennings, seconded by Alderman J. Benson was made to accept the MWPP Resolution. Votes were cast, and the motion carried unanimously.

#### 16. Discussion of Financial Report - CPA

#### Minutes:

Alderwoman E. Jennings requested that we shop local when possible, as she saw other body shops on the expense reports. A Motion was made by Alderwoman E. Jennings, sec<mark>onded by Alderwoman S. Gay to app</mark>rove the Financial report from CPA.

Plain Dealing Proud is also selling tickets for the 50/50 "SPLIT THE POT". Alderwoman E. Jennings stated that Plain Dealing Proud has purchased locally from Rocky Mount Builders two picnic tables. The name "Plain Dealing Proud" will be written on the tables. They will have them installed and secured at the Lake. Alderwoman E. Jennings also commented on the storm and how we miraculously managed to get through the storm with power and water. Alderwoman J. McGuffey wanted to thank the Marshal, And all the Town Employee's and citizens that came out and helped through all the bad weather conditions during the snow storm. Alderman J. Benson Stated that there will be a benefit fish fry for Mr. Wiley Robinson on April 3rd to help with medical expenses, and requested any who wish to participate was welcome. Alderwoman S. Gay asked that everyone keep Mr. Wiley Robinson in their prayers.
