10. NEW BUSINESS:

- A. INTRODUCTION OF ORDINANCE NUMBER 12 OF 2024 AN ORIDINANCE SETTING THE SALARY OF THE TOWN MARSHAL OF THE TOWN OF PLAIN DEALING, BOSSIER PARISH, LOUISIANA to remain at \$38,353.20 per year in addition to all full-time benefits: however, the Town Marshal shall have the option per each four-year term to opt out of the town's health insurance. In event that the chief of police elects to opt out of the Town's health insurance, then in that event, the health insurance premiums that would be paid by the town shall be added in to the Chief of Police's monthly payroll check for the entire four-year term. Emily Jennings made a motion to table the resolution until the legalities are worked out and James Cook seconded the motion. All of the members voted in favor of the resolution. There was no public comment.
- B. THE BOARD OF ALDERMEN WILL consider a Resolution to authorize the Town Attorney to obtain an attorney General Opinion regarding the legality of the proposed ordinance on the chief of police's salary. Shanithia Gay made a motion to approve the resolution and Emily Jennings seconded the motion. All of the members voted in favor of the resolution. This motion carried. There was no public comment.
