- 7. Approve the Expense Report-Mayor Cook asked for an approval for the expense report for the month of May 2025. A motion was made by Shavonda Gay and seconded by Shanithia Gay to approve the expense reports. All of the members of the council voted in favor of the reports. There were no public comments.

## 8. Department reports:

## 10. NEW BUSINESS:

- A. Bill Clements appeared before the board of aldermen to discuss the placement of a wooden fence at the cemetery. The fence will be 48 feet long and 6 feet wide all paid by Bill Clements. Jeff Benson made a motion to accept Mr. Clements proposal and Shanithia Gay seconded the motion. There were no public comments. All members voted in favor thereof.

Joshua Worn, site manager for Waste Connections and Steven Townsley sales manager appeared before the board of aldermen the give updates about the transition. It was stated that Waste Connection will take over beginning June 16, 2025. This will be a lateral transfer and the operations will remain the same for the remainder of the contract. - D. The board of aldermen will discuss the increase of the 2025 millage rate. The current millage rate is 7.35%. The new amount will be 8.73% which will produce an approximate increase of \$7417 with an approximate income of \$46,920.00 in sales tax revenue. After a brief discussion, Jeff Benson made a motion to increase to 8.35% instead of 8.73% starting in 2025. Shavonda Gay seconded the motion. All members voted in favor thereof.
