1.Call meeting to order- Mayor Gay called the meeting to order at 6:00 p.m.

7. Department report=

Police Department - The Chief of Police *reported* that there were 217 civil and criminal calls In June 2024. There were 263 traffic stops. The chief reminded us to be mindful while being outside. Drink plenty of water and try not to get overheated and stay in shade as much as possible. Know the signs of heat injury and if you suspect you have heat injury contact 911.

8. Public Works Department Kevin Whitton gave an updated report of the streets. He stated that there are about 600 meters installed in the ground at the moment. On a motion given by Judith McGuffey to re-appoint Cindy Dodson to the board of commissioners for fire district #7 and seconded by James Cook, the board of aldermen agreed to appoint her for a two-year term. There were no public comments. All member voted in favor of the appointment.

On a separate motion, the board of aldermen were asked to re-appoint Lenora Green-Myers to the Board of commissioners for a two-year term for fire district #7. Emily Jennings gave a motion to re-appoint Lenora Green-Myers to the Board of Commissioners beginning on August 1 2024 and Shanithia Gay seconded the motion. There were no public comments. All of the members vote in favor of the re-appointment.

A. The board of aldermen will consider creating a property standards board. The property standard board will consist of members of the board of aldermen, who when sitting in such capacity, shall be specifically, so convened. Doug Dominick gave a brief overview of the revise ordinance for December of 2023. The ordinance states that the mayor or her designee shall send out letters to citizens that are in violation and they will have ten days to clean the area. ▶ f it not done; the town has the right to clean the property.
