# TOWN OF PLAIN DEALING REGULAR MEETING HELD ON TUESDAY, JANUARY 10, 2023 AT LEON SANDERS JR., MUNICIPAL COMPLEX 205 WEST PALMETTO AVENUE, PLAIN DEALING, LOUISIANA

- 1. CALL TO ORDER Mayor Shavonda Gay, called the meeting to order at 6:03 PM.
- 2. Invocation• Town Attorney, Douglas C Dominick, led all present in the prayer.
- 3. Pledge of Allegiance Alderman Cook led all present in the Pledge of Allegiance.

**Roll Call** - Town Clerk, performed a roll call and verified that the following members were present: Jeff Benson, Shanithia Gay, James Cook. and Judith McGuffey. Absent were: Emily Jennings.

- 4. APPROVE AGENDA: Mayor Shavonda Gay, asked for a motion to approve the agenda. A motion was made by James Cook and seconded by Shanithia Gay All members voted in favor of the approved agenda. There was no public comment.
- 5. Approve Minutes- Mayor Gay, asked for a motion to approve the minutes of the December 20, 2022 minutes. A motion was made by Shanithia Gay and seconded by James Cook. All members voted in favor of the approval of the minutes. There was no public comment.
- 6. Approve the Expense Report-Mayor Shavonda Gay, asked for an approval for the expense report for December 2022. A motion was made by James Cook and seconded by Shanithia Gay to approve the expense report. All members of the council voted in favor of the reports. There was no public comment.
- 7. **DEPARTMENT REPORT-** Police Department Mayor Shavonda Gay read the police department report from the chief of police indicating that for the month of December. The town of Plain Dealing Police Department had a total of 384 calls, 118 were traffic related and 2 traffic violations were written.

Public Works Department -Water/Sewer Superintendent Kevin Whitton gave an Update on the water. He indicated that there were fourteen new meters installed and ten more are on the coming.

#### 9. NEW BUSINESS-

- A. The board of Aldermen will consider the hiring of Henry D Ainsworth as a part- time police officer. Chief Murray has requested that Henry Ainsworth starting rate of pay should be \$13 per hour. Henry Ainsworth is a retired police officer from Springhill and is already post certified. He will not have benefits and is seeking supplemental income.
